MINUTES OF THE CITY OF LAS VEGAS CITY COUNCIL REGULAR MEETING HELD ON WEDNESDAY, MAY 8, 2024 AT 5:30 P.M. IN THE SAN MIGUEL COUNTY CHAMBERS.

CALL TO ORDER

Mayor Romero called the meeting to order at 5:30 pm.

ROLL CALL

PLEDGE OF ALLEGIANCE

MOMENT OF SILENCE

Councilor Montoya asked for a moment of silence for the community, peace on Earth and to end the wars. Councilor Montoya also asked for a moment of silence for those who lost their homes due to the fire and to pray for recovery.

APPROVAL OF AGENDA

Councilor Montoya made a motion to approve the agenda as presented. Councilor Martinez seconded the motion. Mayor Romero asked if all were in favor. All were in favor.

PUBLIC INPUT

There was no public input.

MAYOR'S APPOINTMENTS/REPORTS AND RECOGNITIONS/PROCLAMATIONS

Mayor Romero thanked City staff for all they do.

COUNCILORS' REPORTS

Councilor Casey advised that Councilor Montoya had requested that the street between Mountain View and Legion be opened. Councilor Casey advised that after speaking with several people within the school district, she was informed that after Sierra Vista and Los Ninos schools were built it was changed to a school access road. Councilor Casey advised that the schools would not open the road due to a safety hazard for the children and buses. Councilor Casey apologized for not being able to attend the ground breaking on University Avenue.

Councilor Montoya advised that they had ground breaking on University Avenue for reconstruction. Councilor Montoya advised that it should be completed within 120 days, was a \$2.6 million dollar project and was fully funded by NMDOT. Councilor Montoya thanked NMDOT for funding the University Avenue project. Councilor Montoya discussed attending a MainStream New Mexico Seminar and he also attended the cleaning of the Gallinas River for Earth Day. Councilor Montoya advised that FEMA would be having a Claims Office Resource Fair on May 11th at the Sheridan Volunteer Fire Department. Councilor Montoya advised that he attended the National Day of Prayer along with Mayor Romero.

Councilor Martinez advised that the University Avenue project would be ongoing until September 11th and the parking lot at the Senior Center was close to being completed. Councilor Martinez advised that he attended the Swearing in of Police Chief Caleb Marquez and he attended Friday Al Fresco. Councilor Martinez advised that he gets calls regarding Independence Avenue street repairs.

CITY MANAGER'S REPORT

City Manager Tim Montgomery discussed the following;

Councilor Martinez applauded City Manager Montgomery for being a part of every aspect of the City.

Councilor Montoya advised that he was glad the auction went well and asked if the events were listed on the City's website and if they could place the schedule for Friday Al Fresco in the optic. Councilor Montoya advised that more trash cans are needed along the Gallinas River.

Councilor Casey thanked City Manager Montgomery for all the work he does for the City and advised that City Manager Montgomery is extremely busy and works long hours to ensure everything gets done.

Mayor Romero advised that it's important to work as a team, along with being transparent. Mayor Romero thanked City Manager Montgomery for his leadership.

APPROVAL OF MINUTES

Councilor Casey made a motion to approve the minutes from April 17, 2024, with minor corrections. Councilor Martinez seconded the motion. Mayor Romero asked if all were in favor. All were in favor.

PRESENTATIONS/POSSIBLE DIRECTION

Masie Estep, San Miguel Early Childhood Coalition Coordinator, discussed the Noches De Familia in the Park event that would be taking place on May 14, 2024. Ms. Estep spoke about the funding they received for early childhood needs and the importance of safe outdoor spaces for children. Ms. Estep invited the Governing Body to the Noches De Familia in the Park event on May 14th from 5:30 - 7:30 pm. Ms. Estep advised that they wanted to present the Mayor and Council with a certificate to show that they are a key part of children's outcome.

Councilor Casey, Councilor Martinez and Councilor Montoya thanked Ms. Estep for all the work she has done.

Ms. Estep advised that they would like to have input regarding age appropriate playground equipment at parks.

Mayor Romero thanked Ms. Estep for her presentation and mentioned the importance of building the community up again.

Councilor Martinez asked Ms. Estep to extend a thank you to Elizabeth Ratzlaff who has also done a lot.

CONSENT AGENDA

City Clerk Fresquez advised there were none.

BUSINESS ITEMS

1. Present, review, discuss and potential action on City in support of New Mexico Environment Department proposed water reuse water regulation by Glorieta Geoscience Inc.

City Manager Tim Montgomery advised that he received an email regarding water reuse and potential opportunities that the City could have. City Manager Montgomery advised that he was not part of the previous discussions so he reached out to Glorieta Geoscience to discuss an overview.

Jay Lazarus with Glorieta Geoscience provided a lengthy discussion regarding the New Mexico Environment Department development of water reuse regulations which was an initiative of the Governor's Office. Mr. Lazarus advised that they have been working with the New Mexico Environment Department since the fires regarding potential water reuse regulations. Mr. Lazarus advised that they are not proposing any specific project but they're asking Council for authorization to present testimony to the Environment department in support of the proposed water reuse regulations.

Councilor Martinez asked when they proposed the consideration for water reuse.

Mr. Lazarus advised that it was proposed to the City and Governor Lujan Grisham about six months after the fire had occurred and the Environment department had been working on the proposed regulations for about a year. Mr. Lazarus advised that they're asking the Council to support the Environment department in developing regulations.

Councilor Martinez advised that there are no regulations set forth by the State of NM.

Mr. Lazarus advised that was correct.

Councilor Martinez voiced his concerns regarding the City being the first in NM to support water reuse regulations.

Interim Utilities Director Travis Martinez advised that there are other states that have implemented the regulations. Interim Utilities Director Martinez advised that it is only to move forward with NMED so they could move forward with the water reuse regulation and in the future the City won't be two steps behind if Council supports the NMED water reuse regulations.

Mayor Romero asked if the testimony was part of the reuse of brackish water and fracking water.

Mr. Lazarus advised yes.

Councilor Casey voiced her concerns regarding the regulations being in place first and then the City could look at them and see how it could affect the City's drinking water.

Councilor Martinez advised that he agreed with Councilor Casey, and that the regulations should be in place. Councilor Martinez asked about the Taylor Wells.

Interim Utilities Director Martinez advised that the Taylor Wells have enough water to produce about 20 days to the City and Taylor Well #7 has brackish water.

Mr. Lazarus advised that the Taylor Wells would provide a limited back-up supply for a short period of time and it would take months if not years for the water levels to recover after it is pumped out.

Councilor Montoya asked if other cities have joined in.

Mr. Lazarus advised that NMED interacts with the regulated community, they propose regulations and then the Water Quality Control Commission accepts testimony on the proposed regulations.

Councilor Montoya asked if there are other cities asking for regulations.

Mr. Lazarus advised that he wouldn't know until they have the hearing next week.

Councilor Montoya asked if it was due to the shortage of water during the fires.

Mr. Lazarus advised yes.

Councilor Montoya advised that according to the testimony, it stated moving forward in creating a regulation for permitting all types of water reuse projects.

Mr. Lazarus advised that the City is not proposing any projects other than supporting their regulatory development.

Councilor Montoya asked if Council were to support the testimony and it's taken to the Water Quality Control Commission, what would be the next steps if it would pass.

Mr. Lazarus advised that the next steps would be the department developing regulations for indirect/direct potable water reuse.

Discussion took place regarding having input before regulations are made and Mayor and Council unaware of the testimony.

Mayor Romero advised that they need to be involved in testifying on behalf of issues and opportunities for brackish water and also having their input on regulations for water reuse.

Interim Utilities Director Martinez advised that the testimony was only to support imposed NMED regulations and it has nothing to do with any other projects. Mr. Lazarus advised that Taos, Espanola and Los Alamos discharge their treated wastewater to the Rio Grande and Santa Fe picks it up at indirect diversion on the Rio Grande and treats it to drinking water standards and discharges it back into the Rio Grande where Albuquerque picks it up at their surface water diversion.

Councilor Martinez voiced his concerns regarding not having enough time to have input from Mayor and Council due to deadlines. Councilor Martinez asked what language would be left out should they move forward.

Mr. Lazarus advised that they could take out the Agua Pura specific language and the language be solely regulatory.

Councilor Montoya made a motion to support the testimony for proposed groundwater and surface water protection supplemental requirements for water reuse.

Mayor Romero asked if there was a second.

Due to the lack of a second the motion died.

Mayor Romero asked for a motion to approve the testimony removing Agua Pura from any testimony.

Councilor Montoya made a motion to approve the testimony removing Agua Pura from any testimony.

Mayor Romero asked if there was a second.

Councilor Casey voiced her concerns regarding the process and the regulations being made first and then having input on how the regulations would affect the City's water system. Councilor Casey advised that the Agua Pura portion was never voted on or discussed by Council. Councilor Casey also voiced her concerns regarding who provided the testimony.

Mayor Romero advised that he had a motion by Councilor Montoya and asked if there was a second.

Due to the lack of a second the motion died.

2. Request approval of encroachment agreement between the City of Las Vegas and Rose Marie Padilla.

Community Development Director Lucas Marquez advised that Ms. Padilla's property abuts an arroyo and is the last house on the street. Community Development Director Marquez advised that there was 25 feet of city right of way between the garage and the curb and discussed the possibility of the City selling Ms. Padilla the 9 feet of city right of way. Community Development Director Marquez advised that the structure was built without a building permit.

Attorney Eugenio Mathis advised that Ms. Padilla grew up on the property, and the encroachment doesn't interfere with traffic or the public right of way. Mr. Mathis advised that they had three letters from neighbors indicating they have no objection. Mr. Mathis discussed the cost that Ms. Padilla would have to pay to have the structure removed. Mr. Mathis commended Community Development Director Marquez for his assistance.

Councilor Martinez voiced his concern regarding any utilities being affected.

Community Development Director Marquez advised that the utilities would be on the westside of the street on the opposite side of Ms. Padilla's property and sewer lines run behind her property.

Ms. Padilla advised that her intentions were to divide her land and once she got a surveyor that was when she learned about the encroachment of city right of way.

Councilor Casey advised that the City ordinance states that a permit is required if any work is done on your property. Councilor Casey suggested that the Planning and Zoning Commission review the City ordinance since they approve items that go before them. Councilor Casey voiced her concerns regarding a permit that should have been in place and 9 feet being a lot of land.

Ms. Padilla apologized for not getting a permit and advised that there was a vacant house next to her and a dead end.

Discussion took place regarding not knowing if additional development could take place in the area, what the measurements were of the carport and garage and communicating with the public about getting permits.

Mr. Mathis asked for a clause to be placed in the encroachment agreement that states, "should the City in good faith determine there is additional development needed in the area, the City could revisit the encroachment and eliminate it altogether". Mr. Mathis advised that he doesn't believe any further development would happen in the area.

Councilor Martinez made a motion to approve the encroachment agreement between the City of Las Vegas and Rose Marie Padilla with the clause that should the City in good faith determine there is additional development needed in the area, the City could revisit the encroachment and eliminate it altogether. Councilor Montoya seconded the motion. Mayor Romero asked for roll call. Roll Call Vote was taken and reflected the following:

Community Development Director Lucas Marquez advised that City utilities are encroaching on the property. Community Development Director Marquez advised that the property was purchased in the early 2000s by Roy and Veronica Hernandez.

Mayor Romero asked to go into executive session to be briefed by the City Attorney to see where they were with the situation.

Interim Utilities Director Travis Martinez advised that the Sulzer Group was from Louisiana and they have helped entities from hurricane Rita, hurricane Katrina, hurricane Sandy and over 30 natural disasters. Interim Utilities Director Martinez advised that the company is pending a NM business license based on negotiations taken by the Executive Office.

City Manager Tim Montgomery discussed the reasoning for Disaster Recovery Services and seeking a consulting group that has dealt with multiple disasters and who will look at the total impact to the City of Las Vegas going beyond burned structures and replacement of the Water Treatment Plant.

Interim Utilities Director Martinez advised the consulting group would be like project management by supplying engineers, seeing what type of funding they need to go after and assist the City as far as disaster recovery projects.

City Manager Montgomery advised that they are still working on the RFP for legal services for the City Charter.

Mayor Romero thanked the Governing Body for attending events in the community. Mayor Romero advised that he's received many calls regarding a rumor pertaining to the status of the City Manager and stated that he supported City Manager Montgomery one hundred and ten percent. Mayor Romero advised that he wanted to make it clear that City Manager Montgomery would not be going anywhere while he is Mayor. Mayor Romero advised that they were looking for a transparent and ethical City Manager and that's who City Manager Montgomery is.

Councilor Casey agreed with Mayor Romero.

COUNCILORS' REPORTS

Councilor Casey thanked the Police department regarding traffic control on Mountain View and Legion at both schools. Councilor Casey thanked City Manager Montgomery, Public Works Director Arnold Lopez and Executive Office Manager Mary Jean Aragon for always being responsive to her requests. Councilor Casey also thanked City staff for all the hard work they do.

Councilor Montoya discussed issues at Solid Waste such as hours of operations, the schedule for dumping trailers and trash pick-up delays. Councilor Montoya advised that if Solid Waste is closed they are going to have people dumping trash and tires in alleys, in County or State roads.

Councilor Ulibarri asked if someone could cut the weeds growing around stop signs in his ward.

Councilor Martinez thanked staff for all their hard work and advised that he had attended the Noches de Familia event.

POLICE CHIEF'S REPORT

Police Chief Caleb Marquez gave a detailed presentation regarding the statistics for the Month of April on the following:

- Community Events
- Street Crimes
 - Evidence seized
 - Attended Meetings
- Animal Care Center updates
 - Dogs (28) 4/1/24
 - Feline (18) 4/1/24

- Field Operations Division (patrol) calls
- Information Division/Records
- Travel/Trainings
- Recruitment
- Department vacancies (30)

Councilor Martinez asked how many vacant Police Officer positions there were.

Police Chief Marquez advised thirteen.

Councilor Ulibarri asked if they would be moving the speed trap on Legion.

Police Chief Marquez advised they would be moving it, but they were assisting the construction crew with it during the Legion Drive project.

Councilor Ulibarri asked if they could have Police patrol the area by Rodriguez Park due to people running stop signs.

Councilor Montoya asked if there was state funding available for recruitment.

Police Chief Marquez advised that they still had the Law Enforcement stipend fund and Retention fund available but the monies would revert back if not used by June 30th.

Councilor Montoya commended the Police department staff for staying with the City and suggested having a stand during the 4th of July Fiestas and Balloon Fiestas for recruitment. Councilor Montoya advised that he noticed 28 street lights were out between Hot Springs and 7th Street which could be a safety issue for Police Officers. Councilor Montoya thanked Police Chief Marquez and his department for all they do and for his leadership.

Mayor Romero asked about vacant Communication Specialist positions.

Police Chief Marquez advised that they will be having one Communication Specialist who would be going on leave.

Mayor Romero asked if they had part time Communication Specialist positions.

Police Chief Marquez advised that they do but those who are part time attend school or have other jobs.

FINANCE REPORT

Finance Director Morris Madrid advised that the finance report shows that the City is in a healthy financial condition, other than the Recreation department having a deficit due to summer programs not currently underway. Finance Director Madrid advised that the Solid Waste department was collecting less than what they're spending. Finance Director Madrid advised that all the departments had healthy budgets, primarily due to vacancy savings. Finance Director Madrid advised that the finance report was presented to the Finance Committee and they identified issues of concerns such as \$8 million budgeted for Natural Gas, only \$6.5 was collected and \$4.6 was spent. Finance Director Madrid advised that in general there are no concerns and will finish the fiscal year financially healthy.

Councilor Martinez asked who prepares the budget for Solid Waste.

Finance Director Madrid advised that he works with the Utilities Director and Manager and discussed the process when working on budgets with department Directors.

Councilor Casey asked if she could have a monthly check register emailed to her.

Deputy Finance Director Dominic Chavez advised that he does email a monthly check register to Mayor and Council.

Councilor Casey advised that she did not receive one for May.

Councilor Montoya discussed having a list to see how they could utilize the money from the Enterprise fund, Lodgers Tax fund, Cannabis fund and Opioid fund.

APPROVAL OF MINUTES

Councilor Montoya made a motion to approve the minutes from April 29, 2024. Councilor Casey seconded the motion. Mayor Romero asked if all were in favor. All were in favor.

PRESENTATIONS/POSSIBLE DIRECTION

Elias Trujillo along with David Luna with the Las Vegas – San Miguel Chamber of Commerce provided the first quarterly report for Fiscal Year 2024/2025. Mr. Trujillo advised that they are staffed 7 days a week and they have had a spike in visitors. Mr. Trujillo also spoke about events that they would be having.

Discussion took place regarding what it takes annually to run the Chamber of Commerce.

Councilor Montoya acknowledged Philip Martinez and Angie Lyster for doing a lot while they were with the Chamber of Commerce. Councilor Montoya asked if they send out thank you for visiting Las Vegas letters to those who go into the Visitor's Center.

Mr. Trujillo advised no, they just keep track of how many people go into the Visitor's Center and they speak with them about what Las Vegas has to offer.

Councilor Montoya asked how much the County contributes and if they've considered filing a claim with FEMA.

Mr. Trujillo advised that they receive \$40,000 from the County and no they haven't had that discussion on filing a claim.

Mayor Romero thanked Mr. Trujillo and Mr. Luna for stepping up and advised that Philip Martinez and Angie Lyster had done an awesome job when they were there. Mayor Romero asked to look into Lodgers Tax being able to fund the Chamber of Commerce since they recruit and work with businesses.

Mr. Trujillo advised that Angie Lyster would be helping them on a volunteer basis.

Mayor Romero discussed how the City helps with seed money and non-profits should be generating funding on their own.

CONSENT ITEMS

There were no consent agenda items.

BUSINESS ITEMS

Councilor Casey made a motion to enter into a Public Hearing for Business Items 1-4. Councilor Martinez seconded the motion. Mayor Romero asked for roll call. Roll Call Vote was taken and reflected the following:

City Clerk Fresquez advised the motion carried.

City Clerk Fresquez asked if there was anyone speaking on the issue to stand and be sworn in. City Clerk Fresquez swore in City Manager Tim Montgomery, Interim Utilities Director Travis Martinez and Legal Counsel Ambrosio Castellano.

1. Approval to adopt Ordinance 24-01, amending Gas Ordinance 06-08 and section 255-11 of the Municipal Code.

City Manager Tim Montgomery advised that there were changes made to the ordinances to have consistency for utility billing. City Manager Montgomery advised from the bill date the total payment would be due within 20 days and if payment is not made within the 20 days then after 15 days the bill is considered delinquent. City Manager Montgomery advised that it would help prevent customers from building up a large debt that they can't pay. City Manager Montgomery advised that there were 361 delinquent accounts, 60 were paid and 301 went to shut off and by June 30, 2023 all accounts had been paid and utilities were turned back on. City Manager Montgomery advised from July 1, 2023 to present there were 942 delinquent accounts, 626 were shut off and as of May 2024 there were still 51 accounts that remained in shut off status. City Manager Montgomery advised that communication is not taking place and each utility has a different billing cycle which is causing problems.

City Manager Montgomery discussed the winter assistance repayment method resolution from 2010 that was used to protect consumers by not allowing gas to be turned off. City Manager Montgomery advised that the resolution was not renewed but they do still follow the same guideline to protect consumers during the winter. City Manager Montgomery advised that it was a regulation from the NMPRC stating gas could not be shut off from November 15th through March 15th. City Manager Montgomery advised that they want to help consumers with a payment plan and help them stick to paying on their payment plan.

Councilor Montoya advised that the current ordinance was not working or being enforced and liens being placed on properties for lack of payment. Councilor Montoya voiced his concerns regarding a customer not paying the total amount of the bill and instead partial payments going towards certain utilities and the utilities being shut off.

Councilor Martinez asked if there was a type of budget billing for those who have issues with paying and if there are other types of programs to help assist with paying their utilities. City Manager Montgomery advised that there are types of assistance programs like LIHEAP, but he wants to drive the communication between the City of Las Vegas and the consumers so they don't have large bills where they can't catch up.

Councilor Martinez asked if they needed to adopt the winter assistance repayment method resolution.

City Manager Montgomery advised that they are following the state regulation but internally they could extend the November 15 through March 15 timeframe by renewing the City's resolution.

Mayor Romero advised that it was not the intent of the City to shut off utilities if people don't pay their bill but instead its to protect the consumers before their bill gets too large and they can't pay it.

Interim Utilities Director Travis Martinez advised that customers technically have 35 days before a notice is sent out stating their bill is delinquent. Interim Utilities Director Martinez advised that they have a scheduled cut off day that lets the customer know to go in and make payment arrangements or be turned off for non-payment.

City Manager Montgomery clarified that the 35 days was based on the bill not being due for 20 days and then 15 days later it's considered delinquent for a total of 35 days.

Interim Utilities Director Martinez discussed the process when shutting off utilities, they shut off water first, then gas and then solid waste.

2. Approval to adopt Ordinance No. 24-02 amending Sewer Ordinance 05-12 and Section 340-53 of the Municipal Code.

Councilor Casey asked about pg. 2, section B (4) that states, "The City may disconnect the private service line of the delinquent account from the City

collection line and plug said private line" and what would happen if a neighbor is connected to the same sewer line that was just disconnected.

Interim Utilities Director Martinez advised that everyone should have their own sewer tap but should neighbors be connected to the same line then they would have to establish whose sewer line it was.

- 3. Approval to adopt Ordinance No. 24-03 amending Water Ordinance 05-17 and Section 440-9 of the Municipal Code.
- 4. Approval to adopt Ordinance No. 24-04 amending Solid Waste Ordinance 10-20 and Section 361-10 of the Municipal Code.

- A revenue/expense increase to Fund 282 Senior Citizens Center in the amount of \$6,000 for ALTSD NM Grown Fresh purchase of kitchen equipment.
- A revenue/expense increase to Fund 285 FEMA Project 690381 in the amount of \$14,964,619 for debris removal within city limits.

An expense increase to Fund 610 – Waste Water in the amount of \$55,000, an expense increase to Fund 620
Natural Gas in the amount of \$90,000, an expense increase to Fund 630 – Solid Waste in the amount of \$55,000, and an expense increase to Fund 640 – Water in the amount of \$106,000 to correct and match administrative charges to the respective General Fund budgeted revenue accounts.
